Upcoming Clinic

The Cayuga County Health Department will be hosting a COVID-19 vaccination clinic on Wednesday, September 22, 2021. The clinic will be held at the Fingerlakes mall from 3-4:30pm. Both first and second doses will be available.

All three COVID-19 vaccines will be offered. Moderna and Johnson & Johnson are approved for those who are 18 years of age and older. REGISTRATION IS REQUIRED.

Children 12 years of age and older are eligible for the Pfizer vaccine and a parent or guardian must accompany anyone under 18 years of age at this clinic.
