## **Land Use Purchase:**

RESOLUTION #21-32 OF THE VILLAGE BOARD OF THE VILLAGE OF AURORA REGARDING AN OPTION TO PURCHASE CERTAIN REAL PROPERTY

November 17, 2021

**WHEREAS**, the Village Board of Trustees of the Village of Aurora ("Village Board") has the authority to enter into a transaction for the purchase of real estate pursuant to New York Village Law §1-102 and has deemed it in the best interest of the Village to enter into the Option Agreement with the Inns and to proceed with the acquisition of the Option Property.

**NOW THEREFORE BE IT RESOLVED,** that the Village shall enter into the Option Agreement in the form attached hereto as **Exhibit A** and the Village Mayor is hereby authorized and directed to execute the Option Agreement on behalf of the Village and to also execute and deliver any other documents necessary to prepare for the acquisition and transfer of the Option Parcel to the Village; and

**BE IT FURTHER RESOLVED,** that the Village Board is hereby authorized to pay to the Inns up to \$5,000.00 to purchase the Option Parcel, which sum is understood to be exclusive of transactional fees and costs related to the transaction; and

On motion by Trustee Murphy and seconded by Trustee Miller the Board authorizes the Treasurer to modify the 2021-2022 Budget by moving funding from A599 Unappropriated Fund Balance to A 1940.4 Purchase of Land.

**BE IT FURTHER RESOLVED,** that this Resolution will be filed in the Office of the Village Clerk in files that are readily accessible to the public and made available upon request, subject only to the limitations established by the Freedom of Information Law.

**BE IT FURTHER RESOLVED**, that this Resolution shall take effect immediately.

### **Water System Grant Application:**

RESOLUTION #21-33 OF THE VILLAGE BOARD OF THE VILLAGE OF AURORA
AUTHORIZING SUBMISSION OF A NEW YORK STATE WATER INFRASTRUCTURE IMPROVEMENT ACT
(WIIA) GRANT APPLICATION FOR THE VILLAGE OF AURORA WATER SYSTEM IMPROVEMENTS

WHEREAS, the Village of Aurora (Village) is located in the Town of Ledyard, Cayuga County, New York; and

**WHEREAS**, the Village Board of the Village of Aurora (Village) prepared a Preliminary Engineering Report (PER) recommending improvements to the Village drinking water system; and

WHEREAS, the proposed improvements to such drinking water system includes a New water treatment facility and intake from Cayuga Lake (including a possible partnership with CCWSA for a new alternative regional source); Also included is a transmission main, various distribution system improvements and UV disinfection; and

WHEREAS, the PER shows the estimated costs of these improvements to be \$10,400,000; and

WHEREAS, the NYSDOH has reviewed/approved the PER and has scored the DWSRF Project #18564 with 105 points; and

**WHEREAS**, in compliance with the requirements of SEQRA, the Village of Aurora Village Board, as Lead Agency, issued a resolution on May 11, 2020, indicating that a Negative Declaration had been issued for the Project; and

**WHEREAS**, on May 20, 2020, the Village passed a Bond Resolution, subject to permissive referendum, at a maximum estimated cost of \$10,400,000; and

**WHEREAS,** the Village Board now desires to pursue grant funding for the project under the New York State Water Infrastructure Improvement Act (WIIA) program.

**NOW, THEREFORE, BE IT RESOLVED**, that the Village Board of the Village of Aurora, Cayuga County, New York, authorizes the submission of a New York State Water Infrastructure Improvement Act (WIIA) grant application; and

**BE IT FURTHER RESOLVED,** that the Village Mayor is hereby authorized to submit an application on behalf of the Village for grant funding under the New York State Water Infrastructure Improvement Act (WIIA) Program, and to execute any agreements, instruments or other documents in connection with the Village's acceptance of any such grants and/or the funding thereof; and

**BE IT FURTHER RESOLVED,** that the Village Mayor may authorize any required local match required with respect to financing or grants awarded to the Village for the Project through the use of cash and/or in-kind services; and

**BE IT FURTHER RESOLVED,** that this resolution shall take effect immediately.
