**Ken Larson** (comments attached): Mr. Larson spoke on behalf of the Aurora Historical Society. Mr. Larson addressed the need for Village archival records storage along with the mention of a village hall/community space, and suggested language to include in that section of the plan.

**Tee-Ann Hunter** (comments attached): Ms. Hunter asked for clarification on land use for Wells College campus
