As you may have noticed there was some repair work done on Rt. 90. This was the result of our ongoing dialogue with the NYS Department of Transportation. The Village has applied for a Downtown Revitalization Initiative from the NY Forward program. We partnered with the Cayuga County Department of Planning to develop an application which was submitted to NYS on September 23<sup>rd</sup>. The DRI was explained in a well-attended public meeting on September 19<sup>th</sup>. A much appreciated thank you to those in attendance and your input which was incorporated into our application. The grant carries a value of \$4.5 million. The competition is very strong among all the municipalities vying for this. However, whether successful this time or not, it represents our continuing commitment to the community to have Aurora recognized as a force in NYS to move Aurora forward.

## From the Department of Public Works

**KAYAK RACKS:** The DPW are putting the kayak racks away for the winter. If you have not already done so, please remove your kayak from the village racks ASAP. Thank you for your cooperation!

**DIG SAFELY** has provided the village with materials to help guide you through your project. If your project requires any type of excavation, please contact the Village Code Enforcement Officer or the Department of Public Works.

LEAF BLOWER pickup dates: October 17 – December 16 (weather permitting).

Leaves/brush must be in bags for pickup prior to October 17.

Please pile brush and leaves separately, keep catch basins free from leaves and grass clippings and be aware that **stones and walnuts will not go through the leaf blower!** Brush should be in four-foot lengths or smaller. If you have a large amount of brush or lawn debris, Mike White will drop off the Village's trailer for you to fill as you clean up your yard. Contact Mike at 364-5239. The DPW will do their best to pick up leaves and brush daily, but sometimes they are called away to perform their other duties. Your patience is appreciated.

When the snow flies, once the first sweep is complete, please move your vehicles to a cleared space so the DPW can easily plow the entire road.
