Adoption of Local Law #1 of 2023:

VB Resolution 23-01: Adopting Local Law #1 OF 2023 Entitled
To Amend Local Law #1 OF 2020: To Regulate Land Use and Provide for Historic Preservation

**WHEREAS,** it is the intention of the Village of Aurora to maintain a viable land use law as the Village of Aurora Zoning Law, and

WHEREAS, the current Zoning Law of 2020 requires revisions to correct inconsistencies, and

WHEREAS, it is the Board's intent to maintain a consistent zoning law, and

WHEREAS, this is a Type II Action requiring no further State Environmental Quality Review; and

WHEREAS, at a regular meeting of the Village Board of Trustees of the Village of Aurora, County of Cayuga, State of New York, held at the Village Hall, 456 Main Street, Aurora, New York, at 6:00 p.m. on January 18, 2023, the following members of the Village Board of Trustees being present:

JIM ORMAN, MAYOR MATT BIANCONI JOHN MILLER JANET MURPHY FRANK ZIMDAHL

The instant Resolution came to be heard and considered:

**NOW THEREFORE, BE IT RESOLVED,** by the Village Board of Trustees of the Village of Aurora as follows:

- 1. The Village Board of Trustees hereby determines that the aforementioned Local Law is a Type II action as defined in 6 NYCRR §617.4(b)(9) requiring no further environmental review;
- 2. The Village Board of Trustees held a properly noticed Public Hearing on the Proposed Local Law #1 of 2023 at Village Hall on January 18, 2023 beginning at approximately 6:00 p.m.;

3. The Village Board of Trustees hereby adopts Local Law #1 of 2023 in the form annexed hereto.

#### Introduction of Local Law #2 of 2023:

# VILLAGE OF AURORA BOARD OF TRUSTEES RESOLUTION INTRODUCING LOCAL LAW #2 OF 2023 ENTITLED

"A LOCAL LAW ENACTING A PROPERTY TAX EXEMPTION FOR VOLUNTEER FIREFIGHTERS AND AMBULANCE WORKERS PURSUANT TO SECTION 466-a OF THE REAL PROPERTY TAX LAW"

Introduced by: Trustee Zimdahl Seconded by: Trustee Miller Dated: January 18, 2023

WHEREAS, pursuant to New York State legislation enacted in late 2022, local governments are now permitted to provide a real property tax exemption to volunteer firefighters and/or volunteer ambulance workers on the assessed valuation of their primary residence pursuant to Section 466-a of the New York State Real Property Tax Law; and WHEREAS, the Board of Trustees of the Village of Aurora deems it to be in the best interests of the Village to adopt a Local Law to establish said exemption and to set forth the requirements for eligibility for the same; and WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a Local Law in the Village of Aurora, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act ("SEQRA") with respect to the enactment of said Local Law, therefore the Village of Aurora Board of Trustees shall act as lead agency in this matter; and

WHEREAS, the Local Law is not deemed to have any impact on the environment and thus is not subject to SEQRA pursuant to 6 NYCRR 617.2(b); and

WHEREAS, pursuant an Agreement between the Cayuga County Planning Board and the Village of Aurora adopted on June 25, 2014, the adoption or amendment of a zoning ordinance or local law that does not increase the type or number of uses permitted within a particular zoning district or increase the intensity or density of development permitted within a particular zoning district is <u>not</u> subject to review by the Cayuga County Planning Board pursuant to General Municipal Law § 239(l-m):

## NOW, THEREFORE BE IT RESOLVED, as follows:

- 1. The foregoing recitals are hereby incorporated as if set forth herein at length.
- 2. The Board of Trustees hereby introduces proposed Local Law #2 of 2023 in the form annexed hereto for consideration and adoption.
- 3. The Board of Trustees deems that the adoption of the proposed Local Law is not an "action" as defined by SEQRA in that it will <u>not</u> have an effect on the environment, and thus, is <u>not</u> subject to SEQRA.

- 4. As Local Law #2 of 2023 is not an adoption or amendment of a zoning ordinance or local law that increases the type or number of uses permitted within a particular zoning district, nor does it increase the intensity or density of development permitted within a particular zoning district, no referral to the Cayuga County Planning Board pursuant to General Municipal Law § 239(I-m) is required.
- 5. The Board of Trustees will conduct a Public Hearing at the Village of Aurora Municipal Building on February 15, 2023, at 6:00 p.m., or as soon thereafter as the matter can be heard, for the purpose of taking public comment on, and giving due consideration to, the enactment of proposed Local Law #2 of 2023.
