HABs and Hydrilla

All of you should have received a letter and brochure from the US Army Corps of Engineers regarding the Hydrilla treatment schedule this summer. Treatment for this invasive weed begins on June 28 and runs weekly through August 16. Usually, the treatment will occur on Wednesdays, but it is weather dependent. The Cayuga County Health Department is monitoring all treatments and posts the results at https://www.cayugacounty.us/1540/eradication-project-in-aurora

As in past years, Wells College Water Treatment Plant will cease pumping during the treatment process and resume 24 hours post treatment.

Fireworks Permits

SCAT Van

Need a ride to the grocery store or an appointment? The Village of Aurora contracts annually with the Human Services Coalition of Cayuga County to provide SCAT van service to the disabled and the elderly. Any person over 60 or any person under 60 with a disability that prevents them from using public transportation is eligible to use the service. Contact them at (315) 253-3548. There is a suggested donation of \$4.00 for each one-way trip.
