Cayuga County Planning: Kari Terwilliger from Cayuga County Department of Planning and Economic Development reviewed the FEAF Part 1 of the SEQR process for the proposed draft zoning law and confirmed with the trustees the Village Boards' intent to serve as Lead Agency for the review.

WHEREAS, the Village Board of Trustees of the Village of Aurora ("Village") tasked an Ad-Hoc Committee ("Committee"), with the assistance of the Cayuga County Department of Planning and Economic Development ("CCPED"), to review and prepare amendments to the Village of Aurora Zoning Law ("Law"); and

WHEREAS, the proposed amendments to the existing Law include extensive formatting and organizational changes which necessitate the repeal of the existing Law and adoption of a new Law as its replacement; and

WHEREAS, this new Law will be adopted by the Village Board of Trustees of the Village of Aurora as a Local Law and the Village wishes to consider adoption of the Local Law; and

WHEREAS, the Village, in considering adoption of the Law, is required to comply with the requirements of Article 8 of the New York State Environmental Conservation Law, known as the State Environmental Quality Review Act, and regulations at 6 NYCRR Part 617 adopted thereunder (collectively, "SEQRA"); and

WHEREAS, the adoption of this Law is a Type I Action under SEQRA and as provided in 6 NYCRR §617.4(b)(1), which requires the preparation of Part 1 of a Full Environmental Assessment Form ("Full EAF") and a coordinated environmental review among all Involved Agencies; and

WHEREAS, the Village is the only Involved Agency under SEQRA for adoption of the Law; and WHEREAS, SEQRA requires that a Lead Agency be designated to conduct the environmental review for adoption of the Law; and

WHEREAS, the Village has prepared a Full EAF Part 1; and

WHEREAS, the Village, in adopting the Law, must refer the proposed amendments to Cayuga County for review of countywide or intermunicipal impacts pursuant to §239-I and §239-m of New York State General Municipal Law; now therefore, be it

RESOLVED, by the Village Board of Trustees of the Village of Aurora as follows:

- 1. The Village Board of Trustees declares its intent to be Lead Agency under SEQRA for the purpose of environmental review of adoption of the Law;
- 2. The Village Mayor is authorized and directed to sign the verification on page 13 of the Full EAF Part 1, thereby completing Part 1;
- 3. The Village Clerk is authorized and directed to deliver a true copy of the proposed Law to the Cayuga County Department of Planning and Economic Development for referral in accordance with General Municipal Law §239-I, m & n;
- 4. This resolution shall take effect immediately.

Ethics Policy: The Village Board discussed revising the policy to make it less restrictive and Trustee Zimdahl recommended deleting "employee" from 1.(1), adding "that he/she owns 5% or more interest" in item 1.(2) and changing "relatives" to "relatives living in the same household" in item 1.(5) Following the discussion Trustee Zimdahl moved and Trustee Murphy seconded to amend the recommended revision by keeping "employee" in 1.(1)

- 1. **General prohibition.** A municipal officer or employee may not use his or her official position or office, or take or fail to take any action, in a manner which he or she knows or has reason to know may result in a personal financial benefit for any of the following persons:

 - . (2) His or her outside employer or business; that he/she owns 5% or greater interest
 - . (3) A member of his or her household;
 - . (4) A customer or client;
 - . (5) A relative living in the same household; or
 - . (6) A person from whom the officer or employee has received election campaign contributions from more than \$1000 in the aggregate during the past 12 months.

WHEREAS, the Village Board finds the 2016 Village Ethics Policy too restrictive;

NOW THEREFORE BE IT RESOLVED, that the Village Board revise the Village Ethic's Policy with Trustee Zimdahl's recommendations in section 1.(2) and 1.(5)

Introduction of Local Law #1 of 2024: To Regulate Multi-Family Dwellings in the Village of Aurora

VILLAGE OF AURORA BOARD OF TRUSTEES RESOLUTION #24-01: INTRODUCING LOCAL LAW #1 OF 2024 ENTITLED "A LOCAL LAW TO REGULATE MULTIPLE DWELLINGS IN THE VILLAGE OF AURORA"

Introduced by: Trustee Murphy

Seconded by: Trustee Bianconi

Dated: January 17, 2024

WHEREAS, pursuant to the New York State Multiple Dwelling Law enacted in 1929, and all amendments thereto ("Multiple Dwelling Law"), the legislative body of any Village is permitted to adopt provisions of the Multiple Dwelling Law and make the same applicable to dwellings within the limits of said Village by passage of a local law adopting the same; and

WHEREAS, the Board of Trustees of the Village of Aurora deems it to be in the best interests of the Village to adopt certain provisions of the Multiple Dwelling Law to protect the public welfare of Village residents by ensuring the establishment and maintenance of proper housing standards to ensure sufficient light, air, sanitation and protection from fire hazards; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a Local Law in the Village of Aurora, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act ("SEQRA") with respect to the enactment of said Local Law, therefore the Village of Aurora Board of Trustees shall act as lead agency in this matter; and

WHEREAS, the Local Law is not deemed to have any impact on the environment and thus is not subject to SEQRA pursuant to 6 NYCRR 617.2; and

WHEREAS, pursuant an Agreement between the Cayuga County Planning Board and the Village of Aurora adopted on June 25, 2014, the adoption or amendment of a zoning ordinance or local law that does not increase the type or number of uses permitted within a particular zoning district or increase the intensity or density of development permitted within a particular zoning district is <u>not</u> subject to review by the Cayuga County Planning Board pursuant to General Municipal Law § 239(I-m):

NOW, THEREFORE BE IT RESOLVED, as follows:

- 1. The foregoing recitals are hereby incorporated as if set forth herein at length.
- 2. The Board of Trustees hereby introduces proposed Local Law #1 of 2024 in the form annexed hereto for consideration and adoption.

- 3. The Board of Trustees deems that the adoption of the proposed Local Law is not an "action" as defined by SEQRA in that it will <u>not</u> have an effect on the environment, and thus, is <u>not</u> subject to SEQRA.
- 4. As Local Law #1 of 2024 is not an adoption or amendment of a zoning ordinance or local law that increases the type or number of uses permitted within a particular zoning district, nor does it increase the intensity or density of development permitted within a particular zoning district, no referral to the Cayuga County Planning Board pursuant to General Municipal Law § 239(I-m) is required.
- 5. The Board of Trustees will conduct a Public Hearing at the Village of Aurora Municipal Building on January 31, 2024, at 6:00 p.m., or as soon thereafter as the matter can be heard, for the purpose of taking public comment on, and giving due consideration to, the enactment of proposed Local Law #1 of 2024.

ENTITLED "TO REGULATE SHORT-TERM RENTALS IN THE VILLAGE OF AURORA"

WHEREAS, the Village of Aurora Board of Trustees (the "Board of Trustees") deems it to be in the best interests of the Village to adopt a Local Law to regulate short term rentals ("STRs) in the Village to balance economic opportunity with protections of community character and availability of housing stock for full-time residents.

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a Local Law in the Village of Aurora, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act ("SEQRA") with respect to the enactment of said Local Law, therefore the Village of Aurora Board of Trustees shall act as lead agency in this matter; and

WHEREAS, the Local Law is not deemed to have any impact on the environment and thus is not subject to SEQRA pursuant to 6 NYCRR 617.2; and

WHEREAS, the Cayuga County Planning Board 239 Committee reviewed a previous version, Local Law #5 of 2023, and determined "no inter-municipal concerns and to be of local concern only" and a subsequent review of the revisions is scheduled for January 18, 2024

NOW, THEREFORE BE IT RESOLVED, as follows:

- 1. The foregoing recitals are hereby incorporated as if set forth herein at length.
- 2. The Board of Trustees hereby introduces proposed Local Law #2 of 2024 in the form annexed hereto for consideration and adoption.
- The Board of Trustees deems that the adoption of the proposed Local Law is not an "action" as
 defined by SEQRA in that it will <u>not</u> have an effect on the environment, and thus, is <u>not</u> subject
 to SEQRA.
- 4. As Local Law #2 of 2024 does not significantly change the intent of the law as introduced on November 15, 2023 and reviewed by the Cayuga County Planning Board 239 Committee, intermunicipal concerns are not anticipated for their January 18, 2024 review.
- 5. The Board of Trustees will conduct a Public Hearing at the Village of Aurora Municipal Building on January 31, 2024, at 6:00 p.m., or as soon thereafter as the matter can be heard, for the purpose of taking public comment on, and giving due consideration to, the enactment of proposed Local Law #2 of 2024.
