Mayor Orman thanked everyone for their comments and commended all the hard work by Kari Terwilliger and Evan Tuthill from Cayuga County Planning. Additionally, Mayor Orman congratulated Ms. Terwilliger on her recent promotion to County Planning Director.

Mayor Orman explained that the revisions to the Village Zoning Law require another review by the County 239 committee and the Village Board will vote on the law at their March 20, 2024 meeting.

Right of First Refusal: The trustees discussed the two purchase offers that Wells College received for the parcels on the east side of Rt 90 and north of Poplar Ridge Road. One parcel includes the ball field and vacant land to the east, and the other is the farmhouse property. The Village has right of first refusal on both properties.

Trustee Miller suggested that the Village purchase the ballfield property and work with a developer. Trustee Bianconi questioned if the Village could transfer its right of first refusal to the prospective buyers.

Mayor Orman noted that any purchase by the Village would be a long process of public referenda, bonds, and securing lines of credit. Mayor Orman added that the Village has 30 days from the time of notification by Wells to decide and the deadline is looming.

On motion by Trustee Bianconi, seconded by Trustee Murphy, the Village Board voted to waive their right of first refusal for the ball field property owned by Wells College.
