THE FOLLOWING EQUIPMENT IS PROPOSED:

01- MQ03-LTE-M-FIRE-AV-V2 CELLULAR RADIO WITH INSIDE ANTENNA  
01- HW-AV-ENC CABINET ENCLOSURE

- *UPON SITE ARRIVAL, CONTROL PANEL'S DISPLAY WAS FLICKERING AND DISPLAYED (NO 1 – TELCO LINE 1). THIS CONDITION OCCURRED AFTER A POWER OUTAGE. IT WAS ALSO NOTED THAT THE PRIMARY LINE WAS DISCONNECTED AT TELCO BLOCK IN PANEL. THERE IS NO DIAL TONE ON LINE 2, ONLY STATIC.*
- *THE DIAL TONE GOING TO TELCO ONE IS GENERATED VIA A MODEM LOCATED IN RADIO ROOM. THESE ARE TYPICALLY DIGITAL LINES AND AT TIMES MAY NOT WORK WITH THE CONTROL PANEL'S COMMUNICATOR WHICH REQUIRES AN ANALOG LINE (POTS LINE), WHICH WAS USED AT INITIAL SYSTEM INSTALLATION.*
- ***THE USE OF THE CELLULAR RADIO IS CONTINGENT UPON PROPER SIGNAL STRENGTH WHICH MUST BE DETERMINED FIRST.***
- *IT WAS NOTED THAT THE SYSTEM'S BACK-UP BATTERY IS DATED 2018. IT IS RECOMMENDED THAT A FULL SYSTEM INSPECTION BE CONDUCTED AND DONE ANNUALLY THERE AFTER. THE PRICE LISTED BELOW IS FOR THE RADIO INSTALLATION ONLY.*
