## **New Business**

Resolution to Accept the Engineering Services Proposal and Hire K. Teter Consulting for the NBRC Grant to Replace Filters at the Water Plant

**WHEREAS,** the Village of Aurora is in the process of being awarded the remaining portion (\$534,342.84) of a NBRC grant originally given to Wells College (\$1,000,000.00) for the replacement of the Water Treatment Plant filters and other related improvements (the "Project"); and

WHEREAS, Wells College is no longer operating and has closed; and

**WHEREAS**, the grant program has very specific requirements for the procurement of engineering services for such a project; and

**WHEREAS,** a Request for Qualifications (RFQ) was published in the Auburn Citizen Newspaper on December 12, 2024 and December 14, 2024 for the Village of Aurora to seek an engineer to provide various engineering services associated with the Project; and

**WHEREAS**, K. Teter Consulting (KTC) of Homer, New York was the only engineering firm to submit information in response to the RFQ advertisement; and

WHEREAS, K. Teter Consulting also subsequently submitted a detailed engineering proposal with a total estimated fee of \$75,000.00 to complete all the required services as described; and

WHEREAS, the NBRC grant covers 100% of the K. Teter Consulting fee; and

**WHEREAS,** the Village of Aurora Board of Trustees have reviewed both the KTC qualification statement and the engineering proposal;

**NOW THEREFORE BE IT RESOLVED,** that the Village of Aurora Board of Trustees accept and approve the Engineering Services Proposal and agree to enter into an Agreement with K. Teter Consulting for the Project.
