

**Community Preservation Panel September 3, 2025 Regular Meeting Minutes**

The meeting was held at the Aurora Firehouse meeting room at 7:00 pm

**New Business**

**Application #25-20 from the Inns of Aurora to demolish an accessory building at 348 Main Street (Tax Map #182.13-1-24.114)**

Mr. Guerrette explained that an agreement between the Aurora Ledyard Historical Society (ALHS) and the Inns of Aurora was drafted by the attorney for the Pleasant T. Rowland Foundation, LLC. The ALHS will relocate the building at their expense, petition the Village Board of Trustees to accept the building as a gift to the village archives, and relocate the building on property donated by a village resident. Deadline for removal is October 30, 2025, though an extension may be granted if both parties agree.

Mr. Burkett emphasized that the panel is voting on the demo application *conditioned* on the building being relocated.

On motion by Wendler, second by Morehouse, the CPP voted to approve Application #25-20 with the following conditions:

1. The building will be removed and relocated by the Aurora Ledyard Historical Society
2. If the agreement between the Aurora Ledyard Historical Society and the Inns of Aurora is null & void, the Inns of Aurora will have to come back to the CPP for a new determination.
