Historian (see attached): Dr. Schwab reported on a new display at Patrick Tavern “From Main to the Kicking Tree: Daily Walks in Aurora circa 1905”, recent queries and an update on the Wells College Archives.

Miscellaneous: Tee-Ann Hunter and Ann Balloni, Cayuga Lake Watershed Inter-Municipal Organization (CWIO) representatives for the Village, invited the Trustees to the CWIO meeting on October 22 at Bolton Point.

Old Business

Village Website: IT support, Jon Gans, requested an update from the Board on the ongoing discussions to upgrade the Village website and increase cybersecurity protections. Mr. Gans reminded the Board of the NY State “.gov” mandate and questioned the Trustees plan ahead of the December 21, 2025 deadline. Additionally, Mr. Gans noted that the current website is hosted on a personal server and is not ADA compliant.

Mr. Gans added that several proposals have been brought to the Trustees the past few years, but none have been acted on. Mr. Gans submitted a proposal that he and a business partner generated for the Board to review but also noted that the Village could approach the county or the town and possibly “piggyback” on their .gov account.

Trustee Miller requested that the proposal be itemized and suggested applying for grants to help with costs. Trustees Miller and Bianconi questioned if the WIIA grant for the water plant could be used for the upgrades due to cybersecurity concerns at public utility plants. Ms. Balloni will check with the village engineer.

Letter to the Governor (attached): On motion by Trustee Murphy, second by Trustee Balloni, the Village Board voted to send a letter to Governor Hochul supporting the Owasco Lake Watershed’s update to their rules and regulations.

Local Law #3 of 2025:

RESOLUTION #25-42 to ADOPT AMENDMENTS TO THE 2024 VILLAGE ZONING LAW

WHEREAS, it is the intention of the Village of Aurora to maintain a viable land use law as the Village of Aurora Zoning Law, and

WHEREAS, the Community Preservation Panel (CPP) has requested revisions to Article VII Historic Preservation in the Village Zoning Law; and

WHEREAS, the Village of Aurora Board of Trustees, at their September 17, 2025, regular meeting introduced the amendments to the Village Zoning Law; and

WHEREAS, the Village Board held a public hearing to receive comments for and against the amendments on October 15, 2025; and

WHEREAS, the Village Board received zero (0) comments from the public; and

WHEREAS, the Cayuga County Planning Board GML 239 Review Committee found no inter-municipal impacts and had no comments; and
