Public Hearing for Application #26-08 from Diane Sonnenstein for a deck addition at 353 Main Street

On motion by Wendler, second by Blum, the CPP voted to open the public hearing for Application #26-08 at 7:01 p.m.

Officer Greer confirmed with Mr. Wood that the deck meets the 50' setback from the rear property line. Mr. Greer added that no variance is needed because the footprint of the patio is "pre-existing, non-conforming".

Additionally, Mr. Greer noted that a letter from the south side neighbors agreeing to the project is included in the file.

Mr. Wood requested marking of the water/sewer lines on the property.
